Note 1 - FSM Eligibility Criteria

- * This funding is available to pupils who are eligible for free school meals because of the **benefits or support payments their parents / guardian currently receive.**
- * A pupil currently receiving a **FSM through transitional protection is not eligible for this grant.**

This funding is available to pupils who are eligible for FSM as detailed above for :-

- > Reception and Year 3 of maintained primary schools in September 2019;
- > Year 7 & 10 of maintained secondary schools in September 2019; or
- > Pupils in special schools, special needs resource bases and pupil referral units who are in Reception, Yr. 3 ,Yr. 7 or Yr. 10 in September 2019.

This funding is also available to all looked after children of compulsory school age irrespective of FSM entitlement.

If items have already been purchased for a Learner and they meet the above criteria, a retrospective claim can be made.

To note - Asylum Seeker pupils entering Reception, Yr. 3, Yr. 7 and Yr. 10 in the 2019/20 school year are entitled to assistance under this Funding if they fulfil the eligibility criteria.
